During the financial year ended 31 March 2025, this authority's internal auditor acting independently and on the basis of an assessment of risk, carried out a selective assessment of compliance with the relevant procedures and controls in operation and obtained appropriate evidence from the authority.

The internal audit for 2024/25 has been carried out in accordance with this authority's needs and planned coverage. On the basis of the findings in the areas examined, the internal audit conclusions are summarised in this table. Section 3 - External Auditor Report and Certificate 2024/25

1 Respective responsibilities of the auditor and the authority

Our responsibility as auditors to complete a **limited assurance review** is set out by the National Audit Office (NAO). A limited assurance review is **not a full statutory audit**, it does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and hence it **does not** provide the same level of assurance that such an audit would. The UK Government has determined that a lower level of assurance than that provided by a full statutory audit is appropriate for those local public bodies with the lowest levels of spending.

Under a limited assurance review, the auditor is responsible for reviewing Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with NAO Auditor Guidance Note 02 (AGN 02) as issued by the NAO on behalf of the Comptroller and Auditor General. AGN 02 is available from the NAO website – <https://www.nao.org.uk/code-audit-practice/guidance-and-information-for-auditors/>

This authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The authority prepares an Annual Governance and Accountability Return in accordance with *Proper Practices* which:

- summarises the accounting records for the year ended 31 March 2025; and
- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors

2 External auditor limited assurance opinion 2024/25

Except for the matters reported below on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return, in our opinion the information in Sections 1 and 2 of the Annual Governance and Accountability Return is in accordance with the Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

In accordance with proper practices as per Paragraphs 2.26 and 2.27 of JPAG Practitioners' Guide 2024 the council should maintain a register of the fixed assets, long term investments and other non-current assets that they hold which agrees to the value per Box 9 of Section 2. We note that the council have not included the fixed asset value for buildings within their fixed asset register. The council should look to update their fixed asset register to include all fixed assets of the council.

The External Auditors noted this on the 2023/24 audit report. The council therefore should have answered 'No' to Assertion 7 of Section 1 of the Annual Governance and Accountability Return which relates to taking appropriate action on matters reported from internal and external audit as this issue was repeated this year.

Other matters not affecting our opinion which we draw to the attention of the authority:

The Internal Auditor has provided a 'Yes' response to control objective H on their report which suggests that the council's asset and investment registers were complete, accurate and properly maintained. This contradicts the point raised on the external auditor's 2023/24 report. Therefore, we would have expected the answer to this to have been 'No'.

As part of our intermediate testing, we requested information showing the review of documents including Financial Regulations, Standing Orders and their Code of Conduct. The council were able to evidence that the Financial Regulations and Standing Orders are regularly reviewed. However, as noted within the council's Code of Conduct, it states that the model code is to be reviewed on an annual basis to ensure that it is fit for purpose therefore the council should look to document this review within their minutes during each financial year.
